**Unto Elsbeth Anne Roth, Laurel Queen of Arms,  
and other members of the College of Arms  
From Reynard des Montaignes, Blue Tyger Herald**



**Greetings, learned lords and ladies, and I hope this finds you well.**

This letter contains submissions received in the East Kingdom in fall 1998, and reviewed in Internal Letter 1999-01. It also contains submissions pended from K7 and K8 for redrawing. There are 6 new names or changes of name and 7 new devices, badges, mon or changes of device, for a total of 13 new submissions. There is 1 resubmitted item, a device.

In addition, we request the following correction to the Ordinary and Armorial.

**Elwynne Rowenna of Wentworth**

retain as a badge

*Azure, a cross voided erminois, overall a griffin segreant argent, all within a bordure erminois.*

The lady's present device, *Argent, a sea-cat contourny counter-ermine, tailed sable, and a bordure engrailed azure seme of roses argent*, was accepted by Laurel in March 1994 (4-12-94), without mention of the disposition of the previous device.

The online O&A has the following note:

The following device associated with this name was registered in February of 1986 (via the East) and should have been released? in March of 1994 (via the East):" *(there follows the blazon given above)*

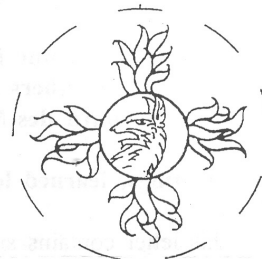
My own records of the internal letter containing *Argent a sea-cat...* (which I prepared, it was R1) show that the lady requested that *Argent, a cross...* be retained as a badge.

If additional paperwork is required to make this correction, please advise us.

It is the desire of the East Kingdom to register the following names and armory:

1. **Aurelia da Calabria** (f) new name

Italian; "Aurelia" was found in Withycombe (no page given), and also in DeFelice, p 82 (under "Aurelio"). "Calabria" is a region in Italy, the "toe" of the "boot" (Bartholomew, Advanced Atlas of Modern Geography). Submitter allows changes for language and/or culture. DeFelice seems to be undated, but refers to cults of male and female saints by this name and to the Roman emperor Aurelian.



2. **Æthelwulf Stealcere** () new badge

*(Fieldless) On a fireball argent flamed proper, a theow's head gules.*

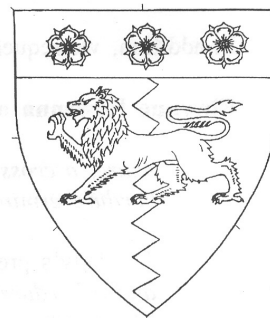
Name registered in July 1996.

3. **Baildrin MacEinri** (m) new name & device

*Per pale indented azure and gules, a lion passant and on a chief argent, 3 roses gules.*

"Baildrin": Son of Philip MacMyles (Died 1288), reported to be the founder of Clan Henir (approx. 1320) in Co. Mayo, Ireland (The Henry Heritage, Joe Henry, 1985 (PCA), ref. History of Co. Mayo by H. T. Knox).

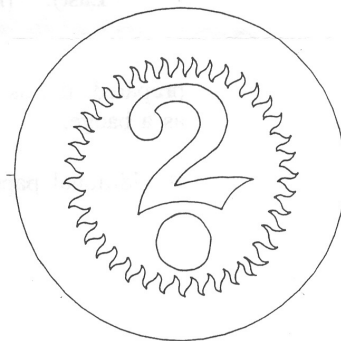
"MacEinri": The Gaelic spelling of the surname Henry. The prefix was dropped early in the 18th century.



4. **Daffyd Ó Nuallain** () new to Laurel badge

*Or, in pale a fleam inverted and a roundel vert within a bordure rayonne azure.*

The name was accepted on K5 and sent to Laurel 1/1999. While many people commented on the wit in the emblazon, this is not a reason for return in and of itself. The only reason that seemed keen was the fact that the fleam was hard to recognize inverted. This could be said of many charges, however, and while it does not make this



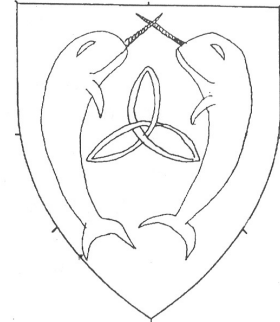
submission 'good heraldry' there is no solid grounds for return.

5. **Deonysia Crowell** (f) new name & device

*Sable, between two narwhals haurient respectant, horns crossed in saltire, a triquetra argent.*

"Deonysia" -- listed in Withycombe under "Denise". Found in Coventry List Book of 1449. "Crowell" -- p. 221, Dictionary of English & Welsh Surnames, Charles Bardsley. Appears on Hund Rolls of 1273.

Clear of Sven Hairy Beermaker (Sep 92), *Sable, between two narwhales haurient respectant, horns crossed in saltire argent, a compass star, and in chief two more Or*, by three CDs for the difference in the secondary charges: type, number, and tincture.

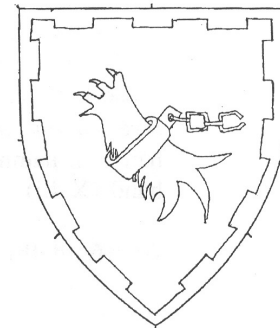


6. **Elsa de Lyon** () resub device

*Azure, a lion's jambe erased bendwise shackled and chained with a broken chain within a bordure argent.*  
*embattled*

Name was registered in January 1996.

The previous submission, *Azure, a lion's jambe erased clasped by a shackle with a broken chain argent*, was returned by Laurel on 10-10-98 for conflict with Fearghus O'Shannon, *(Fieldless) A tiger's jambe couped argent marked sable*. Laurel granted 1 CD for the field, but no difference for lion's jambe vs tiger's, nor for erased vs. couped, nor for the addition of the shackle. The present submission clears this conflict by 3 CDs, one for the field (X.4.a.i), one for bendwise vs. palewise (X.4.h) and one for the addition of the bordure (X.4.b). *Palewise* is the default position for a lion's or tiger's jambe (PicDic, under "leg") and this emblazon clearly shows that the tiger's jambe is *bendwise* (thereby also solving the problem that resulted in the 1996 return).

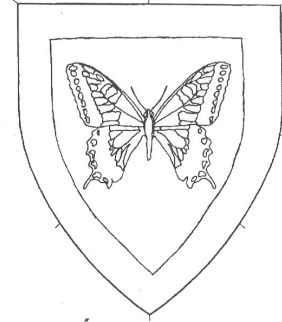
11. **Katarina la Juste** ()

new device

*Or, a swallowtail butterfly within a bordure azure.*

Name was registered in August 1998.

Clear of conflict with Constance von Messer, *Argent, a butterfly azure*, by field tincture and addition of a secondary charge. Clear of conflict with Allanda of Warwick, *Or, a butterfly within six roses in annulo azure*, by type and number of secondary charges.
