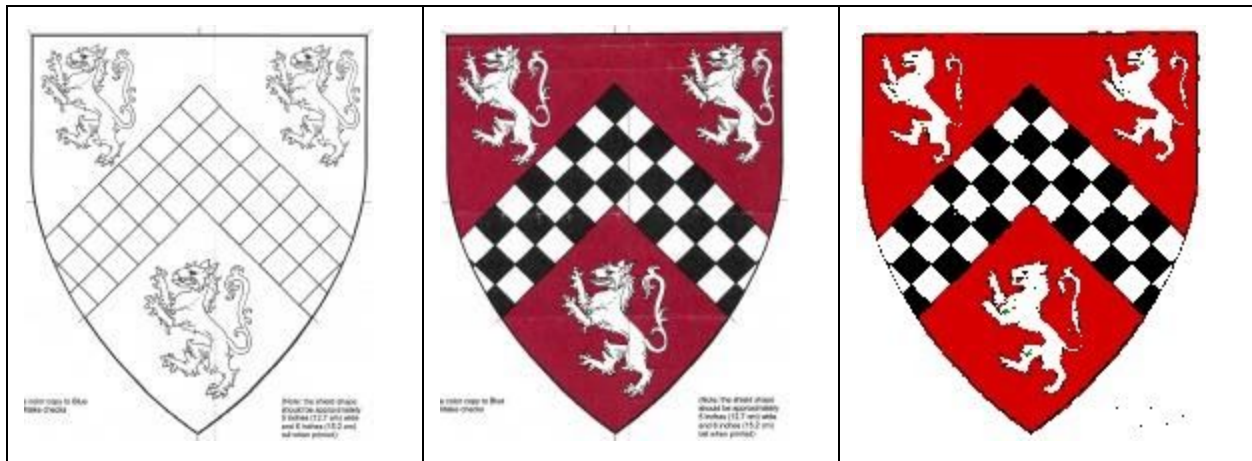
If Muirenn Blue Tyger consulted on any submissions on this letter, decisions were made by Lilie Pantheon and Sláine Diademe.

**1. Adam de Prunay**

Submission	Description	Decision
New Name	Adam de Prunay	Forwarded
New Device	Gules, a chevron chequy argent and sable between three tygers rampant argent	Forwarded



Submitter desires a masculine name.

Client requests authenticity for 12th - 15th century England.

Language (French, close to prunelle) most important.

Culture (French, post Norman invasion) most important.

Meaning (French for Blackthorn; initials AP) most important.

**Adam** is a French masculine given name found in the DNMES dated to 1295

**de Prunay** is a locative French byname found in Names in the 1292 Census of Paris, by Sara L. Uckelman, p 96. <http://www.ellipsis.cx/~liana/names/french/1292paris.pdf>

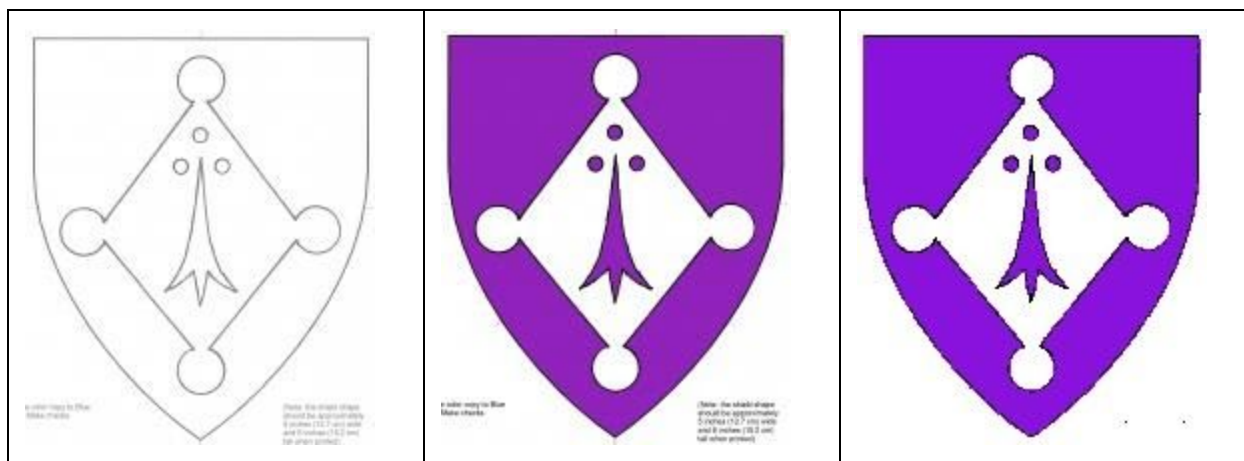
Note: submitter originally wanted the byname <de Prunelle>. If this can be documented to period, submitter would prefer that byname.

## 2. Collette d'Avignon

Submission	Description	Decision
Resub Device	Purpure, on a lozenge pommetty Argent an ermine spot Purpure.	Forwarded



The device blazoned *Argent vetû ployè, an ermine spot purple* was returned on the East 1-15-2020 KLoI for conflict with Adeliza de Clermont's *Or, an ermine spot purple*.

We feel that this redesign addresses the conflict.

### 3. Cuthbert of Brom

Submission	Description	Decision
Resub Device	Or, a cross between four continental panthers rampant sable	Forwarded



This device was originally returned on the February 2020 LoD for conflict with Thomas of Meridies, *Or, a cross between four crosses crosslet sable*. A Permission to Conflict letter is enclosed with the packet and summarized here:

I (Redacted) SKA as Thonas of Meridies give (Redacted) SKA Cuthbert of Brom permission for their armory "Or, a cross between four continental panthers rampant sable" to look similar but not identical to my armory "Or, a cross between four crosses crosslet sable." I understand that this permission cannot be withdrawn once their armory is registered. Signed and Dated 02/05/2020

There was extensive commentary at the kingdom level regarding the drawing of the animate charges in this design. "Blazoned as "continental panthers", this depiction was based on the seal of Rapoto III, son of Count Palatine Rapoto II of Ortenburg as shown above. There was division as to whether a panther could be drawn and identifiable without at least some incensing."

This device is resubmitted with the following proof of variations in depiction of continental panthers.

Non-Core Style Element: A Continental Panther, without incensing.

Time and place: 12th century Carinthia

Proposed Arms: Or, a cross between four continental panthers rampant sable

The images are submitted as proof that panthers in this time frame were drawn without incensing. Please make note that all of the "additional depictions" of Continental Panthers (and one regular Panther) with significantly less incensing than the Mistholme standard above were from later than the 11th century. The sources submitted herein to support the flameless depiction are all from the period in question.

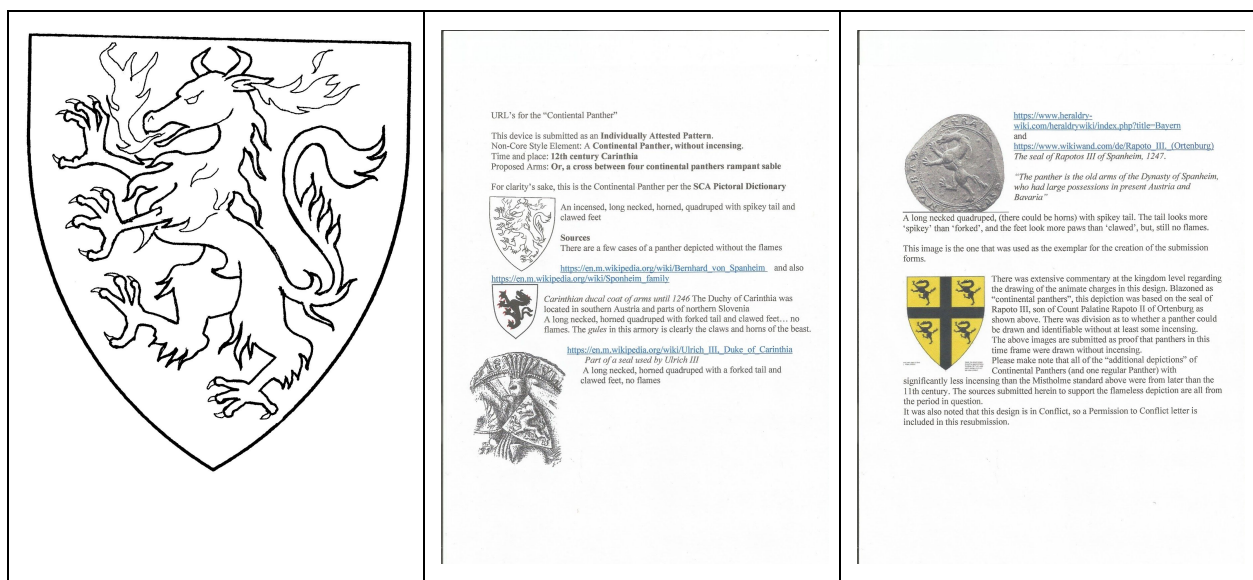
The Continental Panther is described in the SCA Pictorial Dictionary as "An incensed, long necked, horned, quadruped with spikey tail and clawed feet." (See image 1 for visuals)

## Sources

There are a few cases of a panther depicted without the flames.

- Bernhard von Spanheim, Duke of Carinthia (r. 1202-1256). The Duchy of Carinthia was located in southern Austria and parts of northern Slovenia. A long necked, horned quadruped with forked tail and clawed feet, and no flames. The gules in this armory is clearly the claws and horns of the beast. While the arms shown are modern artwork, the seal is from period and also depicts a lack of incensing.

- Ulrich III, Duke of Carinthia (r. 1256-1269). Part of the seal of Ulrich III survives, which depicts a long necked, horned quadruped with a forked tail and clawed feet, and no flames.

- Rapotos III of Spanheim. The seal of Rapotos III survives, which depicts a long necked quadruped (perhaps with horns, the seal is worn) and a spiked tail. The tail looks to be spiked rather than forked, and the feet do not have claws, but there are no flames. This seal was used as the exemplar for the creation of the submission artwork. Modernly, the arms of Bayern continue to depict the panther without incensing.

#### 4. Dana Sanguin

Submission	Description	Decision
New Name	Dana Sanguin	Forwarded
New Device	Per saltire sable and azure, a chimera rampant Or	Forwarded



Submitter desires a feminine name.

No major changes.

Sound (sound similar to legal name) most important.

**Dana** is an English feminine given name found in the grey period Family Search records in the marriage of Dana Veritie, 17 May 1617, Linton in Craven, York, England. Batch M00765-1

**Sanguin** is a French byname dated to 1439 and 1432 in Names from Paris, 1408-1449, by Sara L. Uckelman <http://www.ellipsis.cx/~liana/names/french/paris1408.html>

Per SENA Appendix C, English and French is an acceptable lingual mix, and name elements are within 300 years temporally.

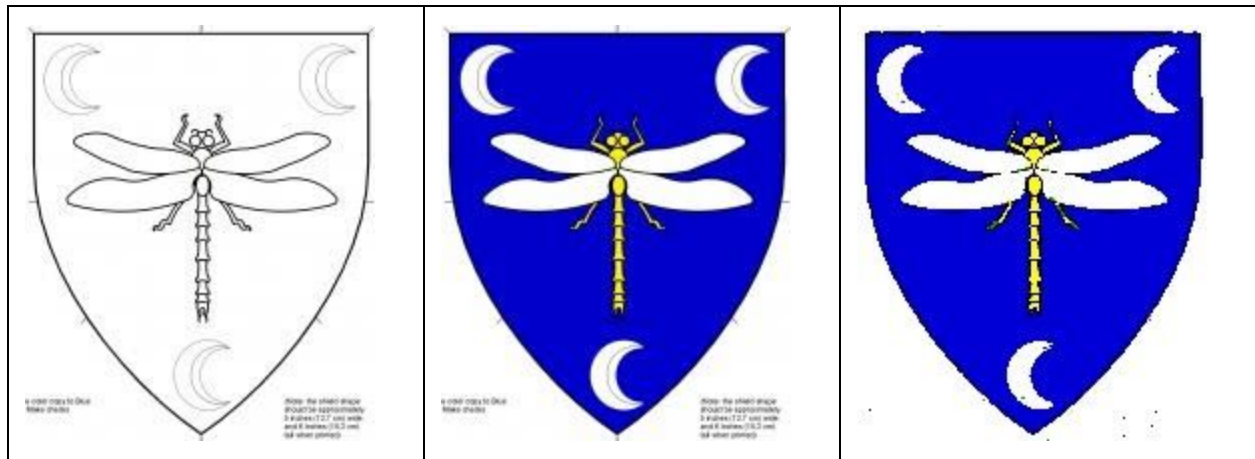
lingual mix. The submitter has no stated preference regarding culture or language.

Iago ab Adam notes that the chimera on the device is not the Society default, and would need a more specific description: *a monster rampant composed of the body and head of a lion, from its back issuing the head of a goat, tailed of a serpent.*

## 5. Fiammetta di Terra del Sole

Submitter desires a feminine name.

No major changes.

Language (none noted) most important.

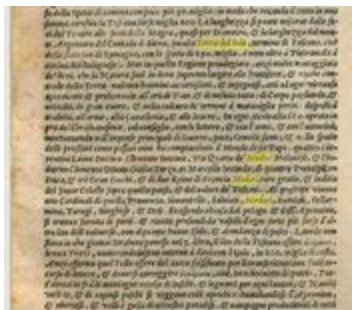
Culture (noted noted) most important.

**Fiammetta** is a feminine Italian given name dated to the 15th and 16th century and found in Late Period Italian Women's Names: Florence by Juliana de Luna

**di Terra del Sole** is a locative byname, using a northern Italian marker as shown in SENA, Appendix A. Terra del Sole is a town in northern Italy created for Cosimo di Medici in 1564 by Baldassare Lanci di Urbino. According to Canzone del S. Gio Battista Elicona nelle sponsalitie della sereniss, Madama Maria Medici & del christianissimo Henrico Quarto, published in 1600, the town existed then.

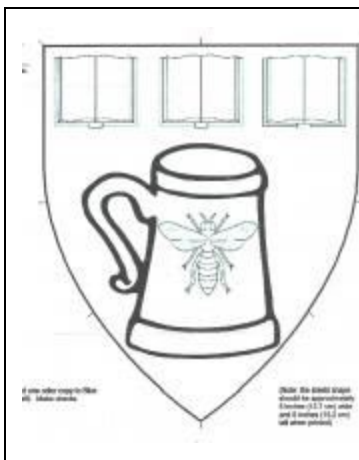

Due to apparent issues with the quality of the black ink on this submission, there is a faint greenish cast to the lines of the black and white emblazon, as well as in the color emblazon. This artifact of printing should not be considered when evaluating this armory submission.

New Device	Per saltire argent and azure, two mullets in pale and a decrescent and an increscent in fess counterchanged	Forwarded



Submitter desires a feminine name.

No major changes.

Language (French/Italian) most important.

Culture (French/Italian) most important.

Spelling (none noted) most important.

**Malorie** is a surname being used as a given name per LoAR of April 2010 (Alton of Grimfells, East). We find the name in Family Search, as the christening of Charles Malorie, 12 Nov 1543, Clifford Chambers, Gloucester, England, batch C02754-1

**de Malenfant** is a French byname dated to 1543 found in Late Period French Surnames (used by women), by Aryanhyw merch Catmael

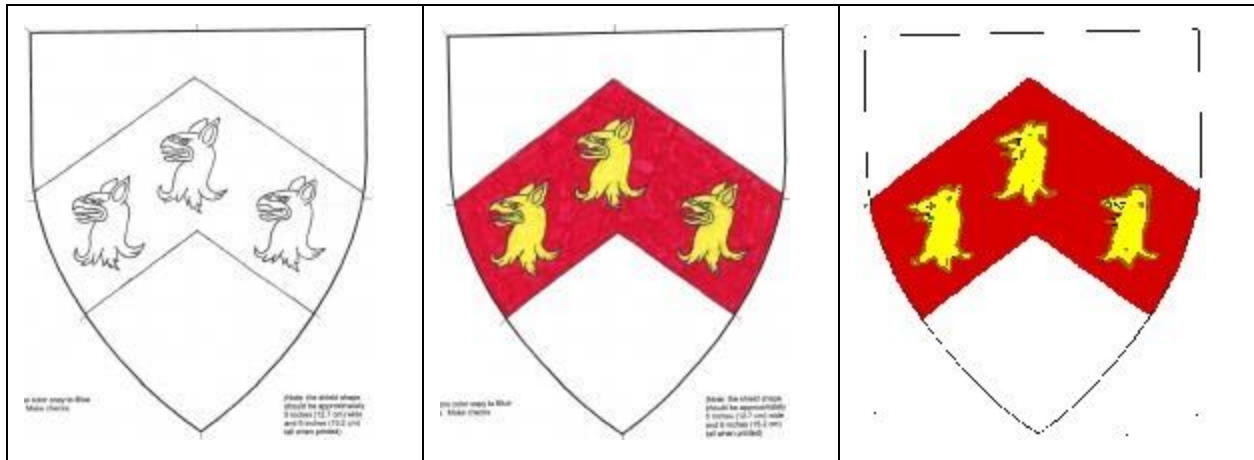
