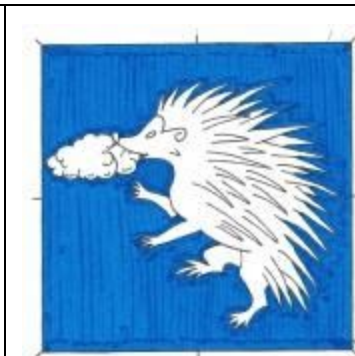
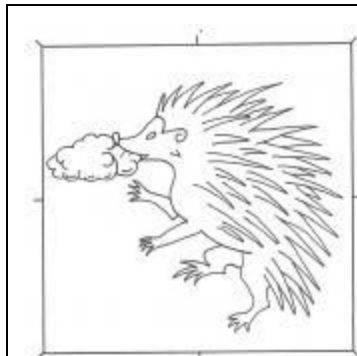
If Muirenn Blue Tyger consulted on any submissions on this letter, decisions were made by Lilie Pantheon and Sláine Diademe.

1. Anne de Basillon

Submission	Description	Decision
New Badge	Azure, a hedgehog rampant maintaining in its mouth a cloud argent	Forwarded

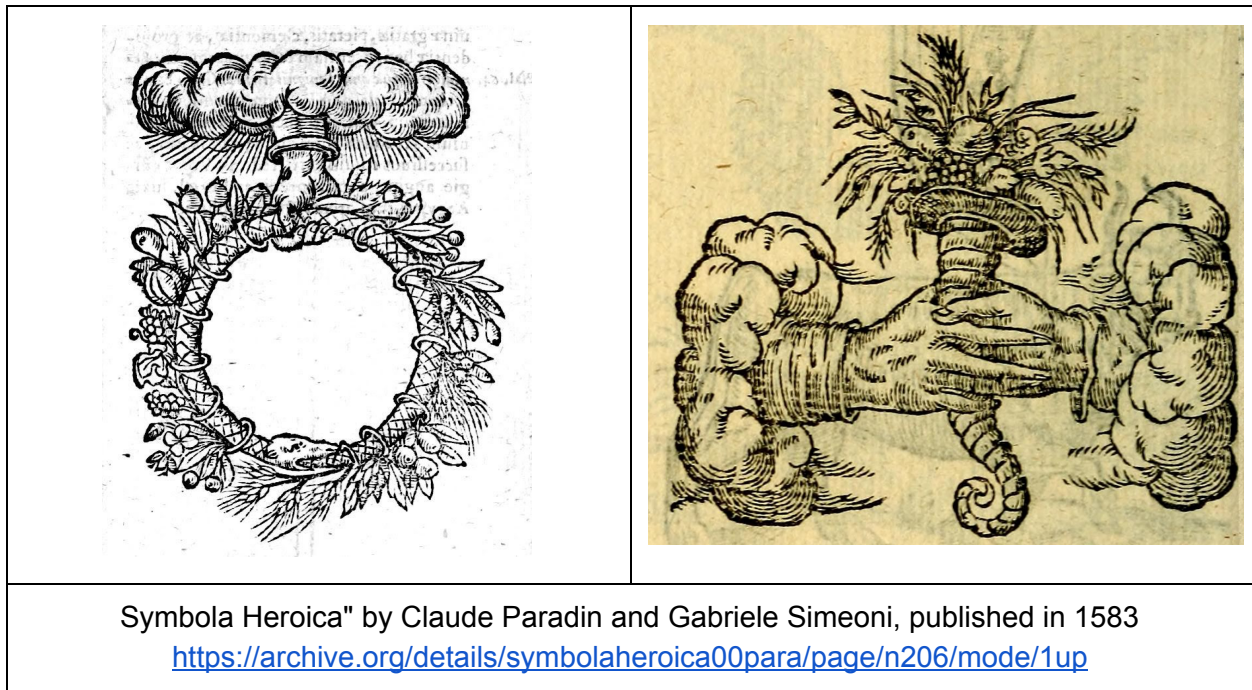
Commenters remarked that it was difficult to identify the cloud in the thumbnail, and that the depiction of the cloud was not the standard heraldic form. We find that past precedent has allowed for different styles of clouds, based on period depictions in armory, and that the evidence of imprese has been acceptable in documenting the form of a charge.

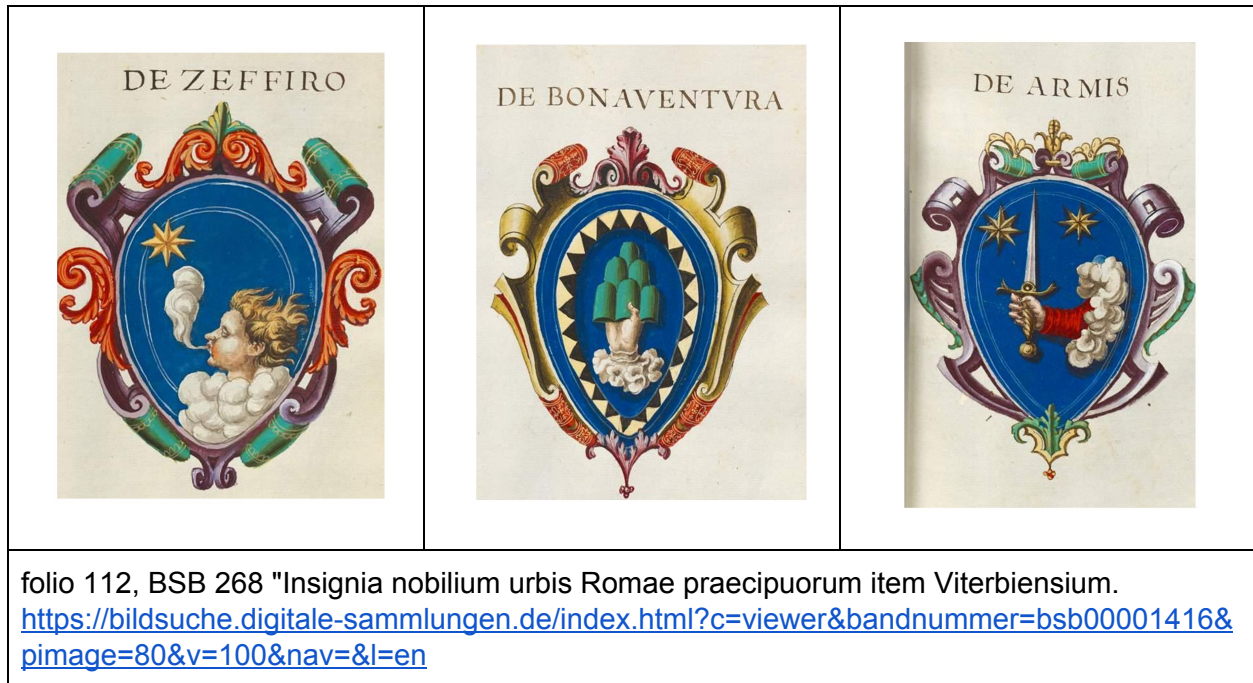
Mathghamhain Elmet provided us with research that depicts more "fluffy" clouds in imprese, found in "Symbola Heroica" by Claude Paradin and Gabriele Simeoni, published in 1583 (<https://archive.org/details/symbolaheroica00para/page/n206/mode/1up>) .

Additionally, we considered the clouds found in various depictions in folio 112, BSB 268, "Insignia nobilium urbis Romae praecipuorum item Viterbiensium."

We feel that this evidence further supports the range of depictions possible for heraldic clouds, including those of a more "fluffy" variety. See below for depictions, links, and precedents regarding clouds.








On acceptable variations of cloud depictions

"Elspet Arbuthnoth. Badge. (*Fieldless*) *A hand issuant from a cloud and maintaining a roundel argent.* Commenters discussed whether or not the clouds in this depiction were identifiable as clouds. A survey of hands and arms issuing from clouds in period armory showed variations from more naturalistic clouds to the more typical nebuly clouds, to some that were so nebuly they looked more like ruffs around the wrist. Given the variation in period armory, we feel this depiction is within reason, although we note that a more nebuly and less rounded base would help identification."

On the acceptability of imprese as reference for armory

Matthäus Lindenhayn von Schaffhausen. Badge. (*Fieldless*) A dragon-headed and iron contourny azure. This badge was returned on the September 2019 LoAR for

lack of documentation of the use of a single andiron in period armory. However, in the commentary for the defining instance of andirons (Diterich Schwarcz, Sable, a pair of dog-headed andirons conjoined respectant and on a chief argent a rose gules, August 2013, A-Meridies) there was an example presented from an impresa from the 16th century Insignia Veneta, Mantuana, Bononiensia, Anconitana, Urbinatia, Perugiensia, 150r (BSB Cod.icon. 274, found at http://daten.digital-sammlungen.de/~db/bsb00001421/image_219) of a single andiron used in an armorial context. The submitter recommended that impresa as an example of the use of a single andiron in period heraldry with the hope that it would also justify the use of a single andiron in a more heraldic form.

Imprese, while not in the same class of work as more typical armory, have nonetheless been acceptable as a reference for armory. In this case, the one provided shows a more realistic depiction than the stylized one found in the submitter's existing device but remains a depiction of a single, unpaired andiron. If this submission depicted the same, non-stylized form, citation of the impresa alone would be sufficient for registration.

2. Áoife inghean Uí Briain

Submission	Description	Decision
New Name	Áoife inghean Uí Briain	Forwarded
New Device	Per chevron throughout vert and sable, two quatrefoil knots and a spear argent.	Forwarded



Submitter desires a feminine name.

Language (none noted) most important.

Culture (none noted) most important.

Áoife is an Irish Gaelic feminine given name found in Index of Names in Irish Annals: Aife / Aoife, by Mari Elspeth nic Bryan and dated to post-1200 in this spelling.

inghean Uí is the clan marker meaning 'daughter of the clan' appropriate for post-1200 in spelling according to Sharon L Krossa's Quick and Easy Gaelic Names, section on clan bynames <https://medievalscotland.org/scotnames/quickgaelicbyname/#clanaffiliationbyname>

Brian is a masculine given name being used as the clan byname in its post-1200 spelling of the lenited genitive **Briain**. It is found in Index of Names in Irish Annals: Brian, by Mari Elspeth nic Bryan <https://medievalscotland.org/kmo/AnnalsIndex/Masculine/Brian.shtml>

Notes:

The documentation for *Áoife* does not include an accent on the first letter. As the submitter allows for all changes, we have adjusted the spelling of the personal name accordingly.

Commenters raised the question of whether *Áoife inghean Uí Briain* would conflict with the previously registered *Eva inghean Bhriain* (Meridies, February 2000). Under previous rules, this would have been a conflict. However, under SENA that is no longer the case (SENA PN3.C.1) In comparing the names *Eva inghean Bhriain* and *Aoife inghean Uí Briain*, we have the addition of the syllable/word |Uí| and the change of the given name's pronunciation - Ee-vah does not conflict with Ay-fah/Ay-vah by the change from Ee to Ay.

We also have this precedent from 2014 regarding the addition of the syllable/word Uí in Gaelic names:

Caoilfhionn inghean Uí Fhaoláin. Name and device. *Gyronny argent and sable, a hurt and an orle azure*. The submitter requested the form Caoilfhionn inghean Fhaoláin if it could be justified. Unfortunately, this is identical in sound to the registered Caelainn inghean Fhaolain. The particle was changed to inghean Uí in order to clear this conflict.

Prior precedents concerning the difference between inghean and inghean Uí reflect the now-obsolete Rules for Submission, which stated that, "Two bynames of relationship are significantly different if the natures of the relationships or the objects of the relationships are significantly different." (in this case, a daughter rather than a relative of some ancestor). Under SENA, we no longer consider the nature of the relationship when determining conflict. Instead, the addition of a syllable (Uí) is enough to clear this conflict under PN.3.C.2, Substantial Change to One Syllable.

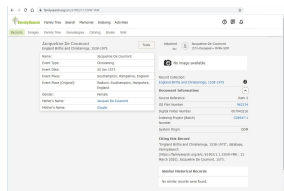

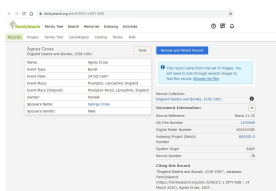

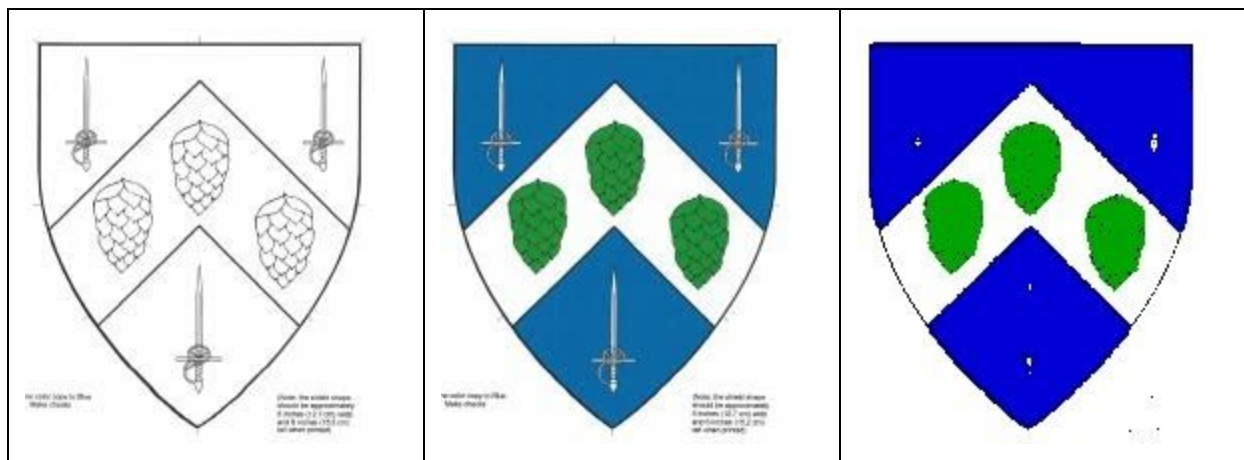

Sound (Lyonesse) most important.

According to Appendix E of SENA, House of is a designator that can be used with an English household name construction. This is also found in Alys Mackyntoich's Alys's Simple Guide to Household Names

In English, the use of only the byname to form a household name is limited, but we do have examples. The CL of March 2013 says, in part: Examples that use only given names, only surnames, or only titles are used in limited contexts. Examples of X's House with given names are found only for saint's names and legendary names, like King Arthur. For surnames, X's House or X House are mostly found in references to actual buildings rather than to people, though they may sometimes be used to refer to the people living in such a building. House of X seems to have been used largely to refer to noble dynasties (like the House of Lancaster and House of York. All of these patterns are registerable.

Lyonesse is a surname found in the Family Search Records:

Submitter desires a masculine name.
Sound (none noted) most important.
Language (none noted) most important.
Culture (none noted) most important.

This is a resubmission from the Laurel level return of Roy de Basillon on the LoAR of October 2019.

This name must be returned for presumption under PN4B1. Roy is a period variant spelling of the French title Roi or "king." PN4B1 states that "[g]iven names that are identical to titles and forms of address may be registered in contexts that make it clear that they are given names and not titles." Because Roy is followed by a locative byname, this name can be read as a claim to be the King of a place named Basillon. Therefore, the name is presumptuous and cannot be registered.

This new submission addresses that presumption with a new given name.

Lucian is a French masculine given name found in the DMNES as a Walloon name in England in 1591. <http://dmnes.org/cite/Lucian/1591/RWC>

de Basillon is a marked locative byname found in Les Grands Annals et Histoire Generale de France, des las venue des France en Gaule jusques au regne du roy tres-chrestieb Henry III, tome 2, published 1579. <http://gallica.bnf.fr/ark:/12148/bpt6k63862332/f1324.image>



Device: This is a resub of a kingdom return on the LoD of 7-26-2019, which states in part:

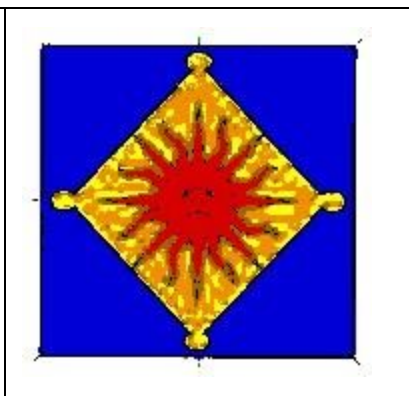
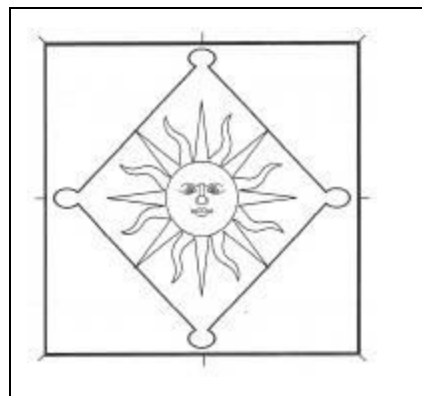
This device is returned for lack of identifiability of the wolf's head. The submitted emblazon used a wolf's head that was neither cabossed nor properly erased. The submitter was advised to choose between cabossed and erased, and provide an emblazon that matches their desire.

We believe this emblazon addresses the issue.

As this was a kingdom return, if it proceeds to Laurel, payment will be due from kingdom to Laurel.
