1: Anna Coelho

Submission	Description	Decision
New Name	Anna Maria Coelho	Forwarded (see Notes)
New Device	Sable mullet Or, on a plate a hare rampant attired sable	Forwarded



Submitter desires a feminine name.

Sound (Similar to Mundane 1st name, as close as possible) most important.

Spelling (Coelho for surname) most important.

Anna is found in "Portuguese Names from Lisbon, 1565" by Aryanhwy merch Catmael (<https://www.ellipsis.cx/~liana/names/portuguese/fem1565.html>).

Coelho is a surname found in "Portuguese Names from the 16th Century" by Juliana de Luna (<http://heraldry.sca.org/names/portugal16.htm>).

Submitter would prefer the given name **Annamaria** if it can be documented.

Notes:

Precedent permits double given names in late-period Portuguese:

The pattern of double given names in Portugal is not found in Appendix A of SENA. After the commentary period ended, Noir Licorne provided a number of late period examples of apparent double given names from the FamilySearch Historical Records in the mid- to late 16th century. Therefore, we can register this name as submitted. We note that this naming pattern appears late, just as for Spanish names. [Christina Jenevra de Carvalhal, 2/2015 LoAR, A-East]

Anna and *Maria* are both found as feminine given names in "Portuguese Names from Lisbon, 1565" by Aryanhwy merch Catmael (<https://www.ellipsis.cx/~liana/names/portuguese/fem1565.html>). Commenters also found *Annamaria* in both Italian and Spanish; given the choice between an Italian or Spanish *Annamaria* and a wholly Portuguese *Anna Maria*, the submitter prefers *Anna Maria*, so we will forward this name as **Anna Maria Coelho**.

2: Anrrique Sandalio Corvo

New Device	Per fess indented sable and argent, a comet bendwise sinister inverted Or and a winged wolf couchant contourny regardant gules	Forwarded



Anrrique is a male given name found in "Portuguese Names from the 16th Century," by Juliana de Luna (<http://heraldry.sca.org/names/portugal16.htm>).

Sandalio is a male given name, possibly a saint's name, found at p. 139 of *Flos sanctorum, fiestas i santos naturales de la ciudad de Cordova* by Martin de Roa, published in 1615. (<https://books.google.com/books?id=NdB8SP-4Lo8C&pg=RA1-PA139>)

Appendix A permits double given names in late-period Spanish. Precedent permits double given names in late-period Portuguese:

The pattern of double given names in Portugal is not found in Appendix A of SENA. After the commentary period ended, Noir Licorne provided a number of late period examples of apparent double given names from the FamilySearch Historical Records in the mid- to late 16th century. Therefore, we can register this name as submitted. We note that this naming pattern appears late, just as for Spanish names. [Christina Jenevra de Carvalhal, 2/2015 LoAR, A-East]

Corvo is a Spanish surname found in the FamilySearch Historical Records:

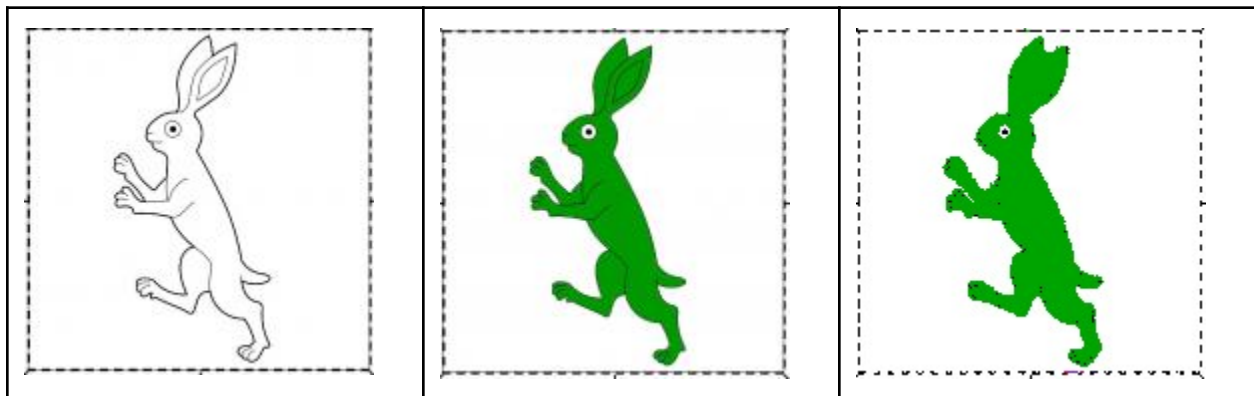

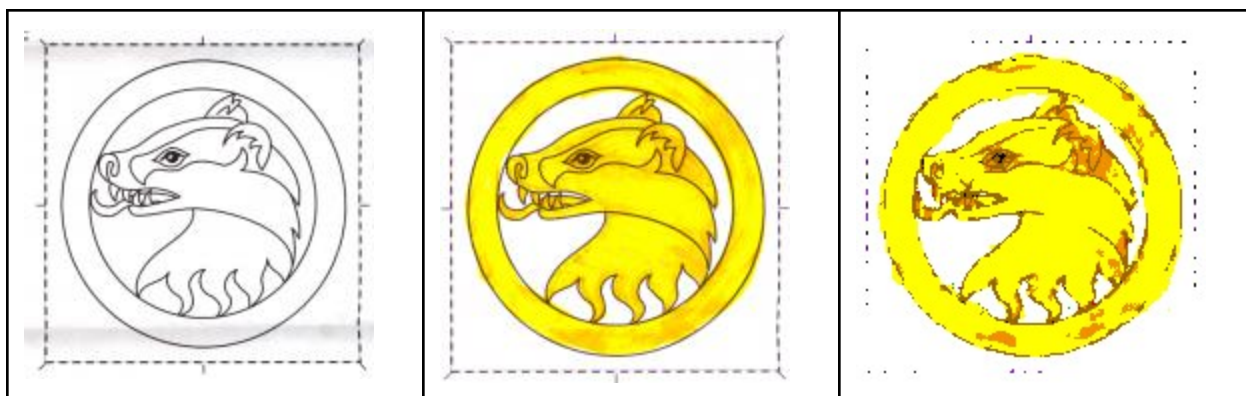

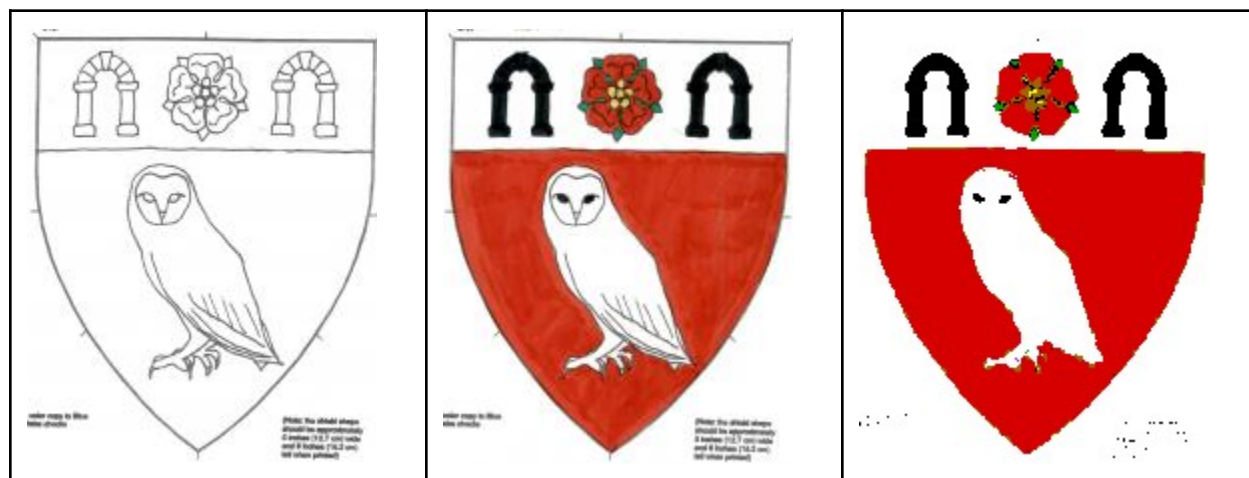

New Device Change	Gules, an owl and on a chief argent a rose proper between two arches sable	Forwarded

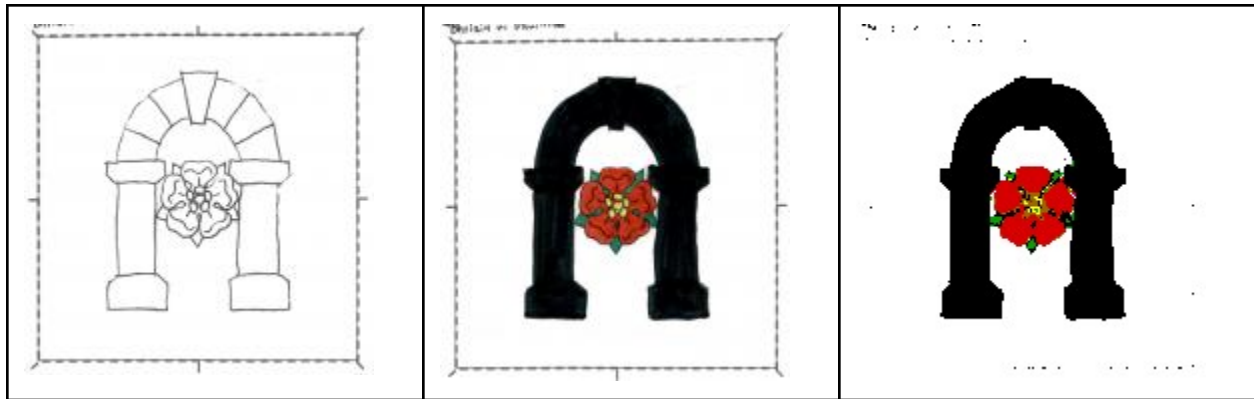


Old Item: *Gules, a rose and on a chief inverted argent three arches sable*, to be released.

New Badge Change	(Fieldless) Within and conjoined to an arch sable a rose proper	Forwarded



Old Item: *(Fieldless) A rose argent within and conjoined to an arch sable*, to be released.

Notes:

Commenters raised the question of whether the rose or the arch is primary, based on the art. Despite the fact that the submitter's previous badge had the rose considered as primary, this design has the arch as the largest charge in the design. Per SENA Appendix I, the primary charge "will typically be the largest charge or charges on the field"; this is reinforced by the March 2009 Cover Letter item regarding charges within annulets: "Which of the two charges is primary depends, as always, on the emblazon." While the final blazon is, as always, up to Wreath, we believe the arch to be primary and have updated the blazon to reflect this.

9: Elisabetta Lucia Portinari

Submission	Description	Decision
New Badge	(Fieldless) On an owl argent maintaining in its beak a rose fesswise slipped and leaved proper, an arch sable	Forwarded



The form incorrectly lists this a "new badge change." However, since the old badge is not being released, but continues to be retained as a badge by the submitter, this is simply a "new badge."

10: Elyas Woderose Henteloue

Submission	Description	Decision
New Name	Elyas Woderose Henteloue	Forwarded
New Device	Per bend gules and Or, a wolf rampant maintaining a needle argent all within an orle of thorn vine vert	Forwarded



Submitter desires a masculine name.

Sound (Sound not specified, asked for 'as submitted') most important.

Elyas is an English masculine given name dated to 1379 in Talan Gwynek's "Yorkshire Masculine Names from 1379" (<https://www.s-gabriel.org/names/talan/yorkshire/yorkm.html>).

Woderose is an English byname dated to 1332 found in R&W s.n. Redrose.

Henteloue is an English byname dated to 1327 found in R&W s.n. Hentwin.

SENA Appendix A notes that double bynames in English are late-period only. Precedent states that double bynames in English in the 13th and 14th centuries may follow the patterns "given+locative+descriptive" and "given+descriptive+locative" [Renard le Fox de Berwyk, 10/2005 LoAR, A-An Tir]; as this name does not follow either pattern, we ask the assistance of the College in documenting this pattern to the 14th century.

If this name is unable to be registered as submitted, the submitter prefers the name "Elyas Woderose".

Notes:

Commenters at Kingdom were able to document *Henteloue* as a 14th-century placename, meaning that the pattern *given + descriptive + marked locative* (Elyas Woderose de Henteloue) would be applicable. The submitter has indicated that they would prefer this form over "Elyas Woderose" if the name as submitted cannot be documented.

However, Scolastica la souriete additionally provided evidence that English single-byname locatives were recorded both marked and unmarked in the 14th century; we believe this is sufficient to allow us to forward the name as submitted under the pattern *given + descriptive + unmarked locative*.

11: Jacqueline Cross

Submission	Description	Decision
New Badge	(Fieldless) A raven displayed purpure	Returned



Notes:

This badge is returned for conflict with the badge of Volradus Tammius, registered in December 2000 via Atlantia: *Per chevron purple and argent, a bird migrant purple*. There is one DC for fieldlessness, but none for the change in posture, and none for the difference between a raven and a generic bird.

Upon resubmission, the submitter is encouraged to choose a shade of purple that is not easily mistaken for sable. While we do not regulate specific shades of heraldic tinctures, we do require charges and tinctures to remain identifiable.

12: Saffke Fischer

Submission	Description	Decision
New Name	Saffke Fischer	Forwarded
New Device	Azure, two bears combatant and on a chief argent a seeblatt azure	Forwarded



Submitter desires a feminine name.

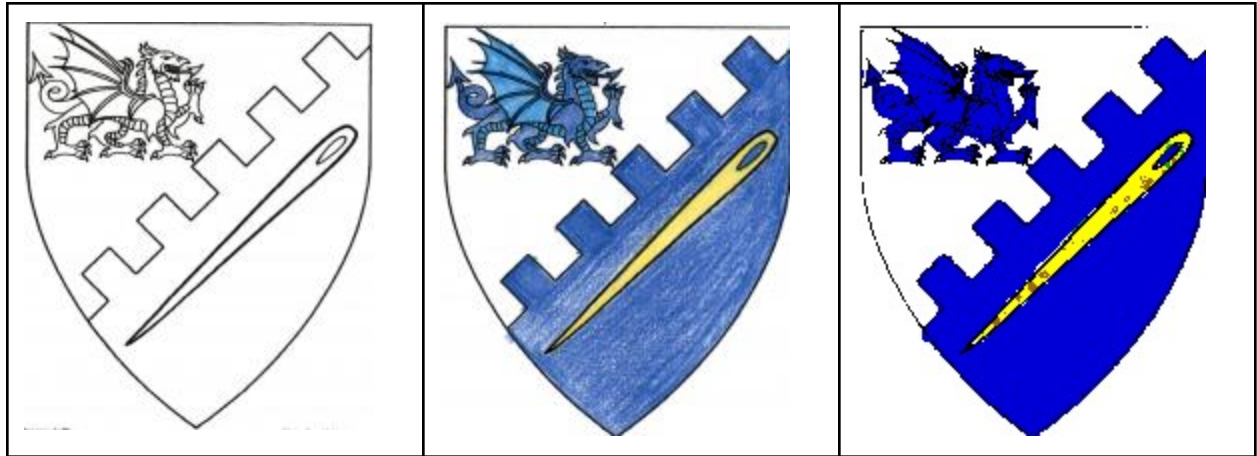
Saffke is a north German version of the given name Sophie, found in Bahlow at p. 434, dated to 1452 in the town of Haldensleben.

Fischer is an occupational byname dated to 1497 in "German Names from Nürnberg, 1497" by Aryanhwy merch Catmael (<https://www.ellipsis.cx/~liana/names/german/surnamesnurna-m.html>).

Notes:
 The documentation provided for *Saffke* does not support this spelling of the name. However, *Ælfyn æt geate* provided evidence for a variety of spellings of this name in Seibicke s.n. Sophia: *Seffeke* (1401), *Saffe* (1406, 1422), and *Seffke* (1496). Given these spelling variants, we believe *Saffke* is a reasonable interpolated spelling for the 15th century, and forward this name for further consideration.

13: Viviana Silvani

Submission	Description	Decision
Resub Device	Per bend sinister embattled argent and azure, a dragon passant contourny azure and a needle bendwise sinister Or	Forwarded



This device is a resubmission of a previous device, *Per bend sinister embattled argent and azure, a dragon passant contourny and a needle bendwise sinister counterchanged*, which was returned on the February 2022 East Kingdom Letter of Decision (<https://bth.eastkingdom.org/wp-content/uploads/2022/02/2022-February-LoD.pdf>) for conflict with the device of Osanna of Stowe (Aug. 2015, via Lochac): *Per bend sinister embattled argent and azure, a crescent and a threaded needle bendwise sinister counterchanged*. This resubmission changes the tincture of the needle in an attempt to clear the conflict.

Notes:

As this was a Kingdom-level resubmission, this item will be marked as New on the external letter, and payment will be due to Laurel.

This concludes the letter of internal kingdom decisions.
