## 1: Amelia Joanna of Atri

Submitter desires a feminine name.

Sound most important.

Meaning (some form of "Amelia Joan" and some form of "Atri") most important.

**Amelia** is a feminine given name found in "16th C Roman Feminine Names" by Aryanhwy merch Catmael, with two instances in this spelling. <<u>https://www.ellipsis.cx/~liana/names/italian/leofemfreg.html</u>>

**Joanna** is a feminine Italian given name recorded in Latin, found in DMNES, s.n. Joan, dated to 1527 <<u>https://dmnes.org/cite/Joanna/1527/Rome1527</u>>

**Atri** is the modern name of the Italian region known in period as Adria, per "Italia: Mercator Place Names in 1554" by Maridonna Benvenuti. Submitter prefers the modern spelling, and would like to use it with di rather than of if possible.

Submitted as Amelia Joanna <u>of Atri</u>, the submitter requested assistance in documenting the modern spelling *Atri* to period in order to form the Italian locative byname *di Atri*. Kingdom commentary was able to cite the requested locative to 1569, fulfilling the submitter's request. The name will therefore be forwarded as Amelia Joanna <u>di Atri</u>.

Submitter has no preference about the gender of the name. Meaning ([unspecified]) most important.

**Bastien** is a masculine French given name as found in "French Names from Paris, 1421, 1423, and 1438" by Aryanhwy merch Catmael <<u>https://heraldry.sca.org/names/french/paris1423.html</u>>

**l'Acculé** is a descriptive byname meaning "the cornered", as per the "Dictionnaire du Moyen Français" <<u>http://zeus.atilf.fr/scripts/dmfX.exe?LIEN\_DMF:LEMME=acculer</u>>.

Pattern of given name + I' + descriptive term in French per SENA Appendix A.

Notes:

The submitter did not provide either direct documentation to support the byname <u>l'Acculé</u> or bracketing examples to support a pattern of French bynames with meanings like "the cornered". Kingdom commentary was unable to source the needed documentation, but felt that it may be plausible to do so with additional time. Therefore, the name will be forwarded with a request for the required documentation of the byname.

Submitter desires a masculine name. Sound ([unspecified]) most important.

Bjorn is an masculine Old Norse given name found in Gerri Bassi p. 8

Garðrsson is a Old Norse patronymic formed from the given name <Garðr> as found in Gerri Bassi p.10.

Notes:

Submitted as Bjorn <u>Garðrsson</u>, the byname is not correctly formed. Old Norse grammar dictates that the parent's name in a patronymic byname be converted to the genitive form. Per Gerri Bassi, for male names that end with -r, the -r is dropped and replaced with an -s, making the grammatically correct byname <u>Garðsson</u>. As the submitter allows all changes, we have adjusted the byname accordingly to allow it to be forwarded.

Submitter desires a masculine name. Language/Culture (Japanese) most important.

**Kashiyama** as a historical surname in the *Sengoku Jinmyou Jiten* (Dictionary of Sengoku Names) (<u>https://sengokudaimyo.com/sengoku-jinmyou-jiten</u>) *Sengoku Jinmyō Jiten* is a biographical dictionary of personages in the Sengoku Period, defined by them as the period 1467-1615.

**Jirou** is a historical yobina found in NCMJ (Rev. Ed.) at p. 371. The submitter would prefer the spelling Jirō if it can be documented.

**Katayori** is a constructed Japanese male given name based on the following elements from NCMJ (Rev. Ed.):

Kata on p. 223 meaning "Tough/Strong" -yori on pp. 245-7 meaning "Request/Ask"


Notes:

Submitted as Kashiyama <u>Jirou</u> Katayori, the submitter requested the yobina to be spelled <u>Jirō</u> if this spelling could be documented. Per SENA Appendix D4b, for Japanese: "We have registered the Hepburn system, as well as that system with two modifications: one that omits all macrons (long marks) and another that uses ou for o-macron". As the spelling requested is the o-macron transliteration of a documented yobina using ou, this can be swapped using the current documentation to meet the submitter's request.

Historically, *Sengoku Jinmyou Jiten* (Dictionary of Sengoku Names) has not been an acceptable source for name documentation alone. However, as some names found in this source have been found to be fully supported by the backing sources by those with access to them, Kingdom forwards this name with a request to Society to help check these sources and see if the element *Kashiyama* is supported.



As previous precedents show a pattern of knots not conflicting with other knots, Kingdom believes this is clear of the badge of Halvdan Stormulv, *Azure, a valknut argent*, with a difference due to the addition of the elder leaves and a difference between a valknut and a mascle knot; and also clear of the device of Lassar ingen Artúir, *Azure, a trefoil knot between three torches argent*, with a difference between the torches and elder leaves and a difference between a difference between a trefoil and a mascle knot.

Notes:

The associated household name, *Oakmont House*, was registered to the submitter in November 2023, via the East.

As previous precedents show a pattern of knots not conflicting with other knots, Kingdom believes this is clear of the badge of Halvdan Stormulv, *Azure, a valknut argent*, with a difference due to the addition of the orle of oak leaves and a difference between a valknut and a mascle knot.

Submitter desires a masculine name. Language/Culture (Italian) most important.

**Vittorio** is an Italian masculine given name found in "Italian Names from the Online Tratte of Office Holders 1282-1532" by Aryanhwy merch Catmael (<u>https://www.ellipsis.cx/~liana/names/italian/tratte/</u>)

**de Corleone** is an Italian byname dated to 1286 in Caracausi, Girolamo, *Dizionario Onomastico della Sicilia*, vol. 1, Palermo, s.n. Corleone. The submitter prefers the umarked *Corleone*, which is permitted in Italian per Appendix A.

## Notes:

Kingdom commentary brought up the possibility of presumption with the character Vito Corleone from The Godfather, as well as that this is not a conflict per SENA PN3C2 and PN3C4 as Vittorio has four syllables while Vito has two and more than two letters have been changed. As presumption must be ruled upon on Society level, Kingdom forwards this for consideration.

**Dimitrii** is a masculine given name dated to 1471 s.n. Dmitrii in Wickenden's "Dictionary of Period Russian Names" (<u>https://heraldry.sca.org/names/paul/d.html</u>). The submitter would prefer the spelling *Dimitri* if it can be documented.

Алехины is a 16th century Russian surname transliterated as **Alekhin** in the nominative (using the Library of Congress transliteration system) found in a book on Russian noble families compiled in 1906 in Russian (<u>http://elib.shpl.ru/ru/nodes/42877-vyp-1-a-b-1906#mode/inspect/page/44/zoom/4</u>) (Images provided)



Submitted as <u>Dimitrii</u> Alekhin, the submitter requested that the given name be spelled *Dimitri* if possible. Kingdom commentary was able to find the requested spelling using a 16th century Turkish source, which per SENA Appendix C is combinable with Russian in late period. Therefore, the name will be forwarded as <u>Dimitri</u> Alekhin.



**Willans** is a place name dated to 1600 in "Highland Place Names from West Aberdeenshire, Scotland" by Mari ingen Briain meic Donnchada (KWHSS 2019) s.n. Willings. According to the article, willans is the Scots term for "willows."

Unmarked locative bynames are found in Scots per Appendix A.





The submitter's original device submission, *Argent, a pole cannon sable enflamed proper*, was returned on the May 2024 Letter of Acceptances and Returns with the following explanation:

This device is returned for conflict with the Barony of the Flaming Gryphon's badge for the Order of the Flaming Brand, *Ermine, a torch sable, enflamed proper*, and with the device of Vladimir Carpatii, *Argent, a torch sable, fired gules within an orle vert.* As there is no evidence of the pole-cannon in period armory, we must judge the difference between the two on appearance, and we do not believe there is sufficient visual difference between a

pole-cannon and a torch, both poles with fire at one end, to be worth a DC. Against the Flaming Gryphon that leaves only a single DC for changing the field tincture, and against Vladimir, a single DC for removing the orle.

The change in orientation of the pole-cannon should add the necessary second DC without introducing any new conflicts.


## Notes:

This device must be returned for conflict with the device of Martin the Juggler: *Argent, a torch bendwise sinister sable, enflamed proper, grasped by a hand bendwise sable.* As shown below, the hand is proportionally smaller than the torch and therefore is considered a secondary charge, only providing one distinct change for its removal. Given the previous precedent set by the original submission which grants no difference between a torch and a pole-cannon, there are no other changes.



## 19. Gregori Rogue Montana

This device must be returned for conflict with the device of Cáelán mac Maíl Dúin: *Azure, a bend vert fimbriated between two morning glories argent*. There is only one distinct change given by changing the two morning glories to the lynx and the boot, and no others.

**Hari** - Hári is an Old Norse name from West Scandinavia found on the Viking Answer Lady website with a citation to FJ pp. 134-135 s.n. Hári (<u>https://www.vikinganswerlady.com/ONMensNames.shtml#h</u>). The submitter prefers to drop the diacritical marking.


**Galti** is an Old Norse byname meaning "boar" found in "Viking Bynames found in the Landnámabók" by Aryanhwy merch Catmael (<u>https://www.ellipsis.cx/~liana/names/norse/vikbynames.html</u>)

**Ulfsson** is an Old Norse patronymic byname constructed from the masculine given name Úlfr found in "Viking Names found in Landnámabók" by Aryanhwy merch Catmael (<u>https://www.ellipsis.cx/~liana/names/norse/landnamabok.html</u>). The submitter prefers to drop the diacritical marking.

A pattern of a central primary charge between a secondary group with another secondary group in base is not a documented pattern per this Appendix, and no documentation was provided to support this arrangement to allow its use.

**Igraine** is a variant spelling of Igrayne, dated to 1480 in the MED s.v. terrible: "his wyf dame Igrayne he put in the castell of Tyntagil". There is an established pattern of English names based on Arthurian characters; Igrayne is the mother of Arthur [Alfarr Utherson, 4/2001 LoAR, A-West]. "Middle and **Eearly** 

Modern English commonly swapped i and y in words." [Elisabetta Tommaso di Carduci, 11/2020 LoAR, A-An Tir].

**Ia Oulle** is a Middle English byname meaning "the owl". Oulle is one of the header forms and "Owl" appears as a surname in the spelling Ulle dated to 1389 in the MED s.v. ŏule. Marked descriptive surnames based on animals are common in English; examples include:

le Bear (1166) and le Urs (1219) found in R&W s.n. Bear le Brid(d) (1235) found in R&W s.n. Bird le Hauek (1296) found in R&W s.n. Hawk le Hayfour (1327) found in R&W s.n. Heifer

This name was on the internal letter under <u>Ingraine</u> la Oulle. As this was a typo introduced on data input that was caught early in commentary, it has been changed to the submitted form <u>Igraine</u> la Oulle and will be forwarded as such.

The submitted documentation used an French naming pattern to defend the pattern of an locational household name documented with an English element. Per SENA NPN1B3: "The designators for household names must be documented as a form describing a group of people in a particular culture. It must be compatible with the substantive element in terms of content and style". Therefore, a household name with an English substantial element must document the designator and pattern to English as well.

However, Kingdom commentary was able to provide documentation for use of the pattern *placename* + *Inn* in English and therefore this submission will be forwarded as is.



Kingdom commentary noted that the gray used for the fieldless background was on the darker side. While Kingdom feels the intention is clear enough to be forwarded as is, we do remind submitters that if they choose to use a gray background for a fieldless badge to add contrast to white charges, that the tone is on the white side of gray and not the black.

It was caught in commentary that the line art version of this badge is drawn differently than the color version, with the tree smaller and not conjoined. As Kingdom did not catch this in pre-processing and Society does not require line art depictions, this will also not stop the forwarding of this badge. However, please note that differences between the line art and the color versions are grounds for administrative return by Kingdom and we may choose to request the art be re-rendered and replaced before accepting the item on a letter of intent.

The submitter's previous submission, *Per pale indented azure and purpure, two ibexes rampant respectant, that in dexter inverted argent* was returned on the April 2018 LoAR:

This device is returned for violation of SENA A3D2c, which requires that "The charges within a charge group should be in either identical postures/orientations or an arrangement that includes posture/orientation." The dexter ibex is inverted, which must be explicitly blazoned separately from the sinister ibex. Also, longstanding precedent does not allow inverted animate charges in SCA heraldry except when in a recognized arrangement such as in annulo. The submitter provided evidence of an ibex inverted in period manuscripts; however, none were in a heraldic context. Without such evidence the longstanding precedent does not allow inverted animate charges in SCA heraldry except when in a recognized arrangement such as in annulo.

The submitter's resubmission, *Per pale azure and purpure, two ibexes courant in annulo argent*, was returned on the Feburary 2020 LoAR:

This device is returned for lack of identifiability of the posture of the ibexes. In the September 2019 return of the badge of the Barony of Borealis, (Fieldless) Two wolves courant in annulo argent, it was ruled: "Submitted as courant, the wolves' postures have been bent into an annular shape, blurring the distinction between courant, statant, and passant. Precedent currently in force requires charges to be identifiable while in annulo, and this does not meet the metric. Upon resubmission, submitters should familiarize themselves with the August 2019 Cover Letter's updated ruling on charges oriented in annulo." We offer the current submitter the same advice.



Per the Pictorial Dictionary of Heraldry, an ibex as a heraldic monster has straight horns, and a natural Ibex has backwards curved horns <<u>https://mistholme.com/dictionary/ibex/</u>>. The forward curvature of the horns in this depiction caused many commenters to not be able to identify the item as ibexes. Given their small size and lack of any other indication, the ibexes need to be redrawn in order to allow them to be identifiable.







Kingdom commentary noted that the depiction of the dragon used in this device does not show the wings as half the dragon's size, as established per precedent: "Please advise the submitter that on resubmission the dragon's wings should be roughly half the dragon." [Rakel Kyrre, 09/2007, R-Atlantia]. Given that identifiability seems to be maintained despite the wing size, the position of the dragon necessitates a more squashed scale, and the depiction used is from The Book of Traceable Heraldic Art <<u>https://heraldicart.org/dragon/#dragon-passant-2</u>> without note, Kingdom declines to redraw and brings this question to the attention of the College for consideration.

This item was returned on the October 2018 LoAR for conflict with the badge of Rowan Perigrynne, *Vert, a cinquefoil within a bordure argent*, as a lily affronty is equivalent to a sexfoil, which bears no difference from a cinquefoil.

The submitter obtained permission to conflict against the above and resubmitted the same design, however, this resubmission was returned on the East Kingdom May 2023 LoD:

This device is returned for conflict with the device of Charles Aythen (1/1996 via Atlantia): *Vert, a rose slipped and leaved a bordure Or.* Just as there is no difference for type between a sexfoil and a cinquefoil, there is no difference for type between a sexfoil and a rose. As we consider slipping and leaving of roses an artistic detail not worth difference (Phaedra de Courcelles, 6/2015, R-Lochac), there is only one DC for the difference in tincture of the flowers.

Additionally, this device is returned for conflict with the device of Margaret of Kingston on Thames (8/1987 via An Tir): *Counter-ermine, a rose argent within a bordure Or.* There is one DC for the change in tincture of the field.


The submitter believes the addition of the lozenges clears all previous conflicts.




