



# 1: Alfarr Skegglauss

Action	Description	Decision
New Device	Vert, on a bend between a ash tree eradicated and a crescent argent, three bees sable marked Or	Forwarded








#### Notes:

The initially submitted art appeared to have black leaves on the tree, which would be a violation of SENA A3B4 as trees get their contrast color from the leaf tincture and therefore this would have low contrast with the green field. However, it was determined during commentary that the submitter intended for the whole tree to be white and that the initially submitted art did have white leaves but internal detailing, processing, and scale rendered them black. The digital copy of the original art was provided, but unfortunately this also suffered the same fate at smaller sizes due to the internal leaf detailing. Therefore, adjusted art was presented to the submitter that removed some of the internal detailing, and the submitter has approved the new art, allowing this to be forwarded.



#### 2: Buckland Cross, Barony of

Action	Action Description	
New Heraldic Title	Sable Massacre Pursuivant	Forwarded

The heraldic title element pattern: [heraldic tincture] + [charge] + Pursuivant is found in SENA Appendix E3 as well as "Heraldic Titles from the Middle Ages and Renaissance: Standard Forms by Origin and Country" by Juliana de Luna, under Heraldic Titles Derived from Heraldic Charges <a href="https://medievalscotland.org/jes/HeraldicTitlesSCA/heraldic titles">https://medievalscotland.org/jes/HeraldicTitlesSCA/heraldic titles by type.shtml></a>

Sable is the heraldic color word for black, for use in non-personal names per SENA Appendix E5.

**Massacre** is a period heraldic charge term for a deer's rack of antlers as found in the PicDic: "The deer's full rack of antlers may be termed a "deer's attires", or a "massacre"" <a href="https://mistholme.com/dictionary/horn-animals/">https://mistholme.com/dictionary/horn-animals/</a>>


A sable massacre is also the primary heraldic charge for a badge of the Barony of Buckland Cross: Argent, a massacre within a bordure embattled sable

#### Notes:

Kingdom commentary brought up previous precedents around possible offensiveness with using the massacre charge as a non-personal name element. While only Society can make decisions on offensiveness, we note that current precedent does not disallow the use of color + massacre as a substantial element: "...The substantial element here, however is Silver Massacre, rather than "massacre" alone. As the addition of the color here is not one commonly associated with violence and slaughter, we hereby rule that this household name does not fall afoul of SENA NPN5B5." [Llewellyn Walsh, 02/2025, A-East]. Therefore, we forward this submission and raise this question for Pelican to decide.

#### 3: Gwyn De Vere

Action	Description	Decision
Resub Device	Per bend purpure and argent, an owl argent and a Celtic knot vert	Returned



The submitter's previous device submission, *Per bend purpure and argent*, was returned on the EK April 2025 LoD:

This device must be returned for conflict with:

- The device of Idonea Lazenby: Per bend engrailed purpure and argent. One distinct change is granted for the complex line vs the plain per SENA A5G1c but that is the only one.
- The device of Agnes Ville: Per bend purpure and checky argent and purpure. There is one
  distinct change for the change of the argent section to checky argent and purpure per
  SENA A5G1a, but as these devices share a tincture on the other half of the field, there is
  no significant change per SENA A5F2 and no other distinct change is present.
- The badge of Cormac Mór: Per bend Or and argent. As with the previous, there is only one distinct change for half the tincture of the field and no other.
- The badge of Giovanna Luigia di Milano: Per bend purpure and gules. As with the previous, there is only one distinct change for half the tincture of the field and no other.

This submission has added primary charges, clearing the device of the above conflicts.

#### Notes:

This device must be returned for violation of SENA A2B5, which disallows the use of Celtic knotwork as a charge: ""Unregisterable Elements: Some items are generally unregisterable. Examples include...period artistic elements that are not found in armory, such as the Greek 'key' pattern or Celtic knotwork."

As well, this could be returned for violation of SENA A3D2a: "Slot Machine: There are some period examples in which a single charge group contains charges of more than one type. Therefore, we allow two types of charges in a single charge group....a charge group with more than two types of charges is not allowed." The circle surrounding the Celtic knot can be considered a separate charge, making it so there are three types of charges with the same weight and therefore in the same group: the owl, the knot, and the annulet.

The submitter may like to know that there are a multitude of knots that are found in period armory, and we recommend if this element is still wanted to evaluate if one of those will be sufficient.

## 4: Rose le Fey

Submitter has no preference about the gender of the name. The following changes are allowed: rose is most important Meaning most important.

**Rose** is a English given name dated to 1332 as found in "Lay Subsidy Rolls of Lincolnshire, England" <a href="https://www.s-gabriel.org/names/mari/LincLSR/GivR5.html">https://www.s-gabriel.org/names/mari/LincLSR/GivR5.html</a>


**le Fey** is an English byname taken from French, also dated to 1332 as found in Academy of Saint Gabriel Report 2815 <a href="https://www.panix.com/~gabriel/public-bin/showfinal.cgi?2815+0">https://www.panix.com/~gabriel/public-bin/showfinal.cgi?2815+0</a>

## Notes:

Kingdom commentary presented a possible conflict with *Rois O Faye*. As *O* is neither an article nor a preposition but *Ie* is, this may clear the name with a change of an entire syllable per SENA PN3C2, but there is currently no found precedent that clarifies if this applies in this type of case. Therefore, we forward this submission and raise this to Pelican's attention.





# 7. Thorstein of Quintavia

Action	Description	Decision
New Badge	Argent, a chief triangular azure and a point pointed vert, overall a serpent in annulo vorant of it's tail	Returned



This submission is to be associated with Company of the Black Wyrm

The association name is currently on the May 30th East xLoI

#### Notes:

This badge is returned for violation of a long standing precedent against having charges overlie a peripheral charge: "It was ruled some five years ago that flaunches should not be surmounted by charges (Wilhelm von Schlüssel, April, 1983) and we see no reason to reverse that ruling." (Alisoun MacCoul of Elphane, LoAR 23 April 1988, p. 16). Barring evidence that such was done in period, we see no reason to overturn this precedent." [Andrés Miguel Rodriguez de la Rosa, 07/1999, R-Caid]. In this case, the snake is overlying the base, which is considered a peripheral charge.

This badge is also returned for violation of SENA A3F4: "Excessive Counterchanging: While counterchanging was common in period armory, it was used mainly with two or four part divisions of the field....Central ordinaries may be counterchanged over other simple ordinaries, as there are a few examples of patterns like *Argent, a pile sable, overall a chevron counterchanged* in late period England. Any other counterchanging of charges over other charges must similarly be attested to be registered." The counterchanging of the snake over the base was not supported by period evidence, and as the snake is not an ordinary and the snake is not counterchanged over the field, it does not fit the allowed cases not needing attestation.

#### 8: Violet Hughes

New Alternate Name	Nedjem-Anch sat ne Pamis	Forwarded

Submitter has no preference about the gender of the name. Language/Culture (Egyptian) most important.

**Nedjem-Anch** is a feminine Egyptian given name as found in Trismegistos <a href="https://www.trismegistos.org/nam/detail.php?nam\_id=13306">https://www.trismegistos.org/nam/detail.php?nam\_id=13306</a>

**Pamis** is a masculine Egyptian given name as found in Trismegistos <a href="https://trismegistos.org/nam/detail.php?nam\_id=7275">https://trismegistos.org/nam/detail.php?nam\_id=7275</a>>

The construction given name + sat ne + father's given name is found in "Names from Demotic Egyptian Sources" by Sneferu sa Djedi mewetif Merit
